Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of AGE Limited (the Company), which comprise the balance sheet as at 31 December 2020, the trading account statement, statement of profit or loss and statement of changes in equity for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements of the AGE Limited are prepared, in all material respects, in accordance with the accounting policies outlined in Note 1 to the financial statements.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (New Zealand) (ISAs (NZ)). Material Uncertainty Related to Going Concern

We draw attention to Note 1 in the financial statements, which indicates that the Company incurred a loss during the year ended 31 December 2020 and, as of that date, the Company's current liabilities exceeded its current assets by \$2,475,835. As stated in Note 1, these events or conditions, along with other matters as set forth in Note 11, indicate that a material uncertainty exists that may cast significant doubt on the Company's ability to continue as a going concern. Our opinion is not modified in respect of this matter.

Notes to the Financial Statements

AGE Limited

For the year ended 31 December 2020

1. Statement of Accounting Policies

Reporting entity

The financial statements presented here are for the entity AGE Limited, incorporated under the Companies Act 1993.

Nature of business

The company is engaged in operation of a school. The nature of the company's business has not changed during the year under review.

Basis of preparation

The director have chosen to prepare special purpose financial reports which may not necessarily comply with generally accepted accounting practice.

The financial statements have been prepared for one or more of the following parties:

- the entity's owners
- Inland Revenue; or
- the entity's financiers.

Historical cost

These financial statements have been prepared on a historical cost basis.

Functional currency

The financial statements are presented in New Zealand dollars (NZ\$) and all values are rounded to the nearest NZ\$.

Share capital

As at 31 December 2020, the company has issued 1,000 ordinary shares. Each fully paid ordinary share confers on the holder one vote at a meeting of the company, a share in distributions approved by the Directors, and a share in distribution of the surplus assets of the company on dissolution.

Changes in accounting policies

There has been no changes in accounting policies. All accounting policies were applied consistently during the year.

Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable for the sale of goods and services, to the extent it is probable that the economic benefits will flow to the company and revenue can be reliably measured.

Sales of services are recognised in the period by reference to the stage of completion of the transaction at the end of the reporting period.

Interest received is recognised as interest accrues, gross of refundable tax credits received.

Accounts receivable

Accounts receivable are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less an allowance for any uncollectable amounts. Individual debts that are known to be uncollectable are written off in the period that they are identified.

Property, plant & equipment

Property, plant and equipment are stated at historical cost less any accumulated depreciation and impairment losses. Historical cost includes expenditure directly attributable to the acquisition of assets and includes the cost of replacements that are eligible for capitalisation when these are incurred.

All other repairs and maintenance expenditure is recognised in profit or loss as incurred.

Depreciation is calculated on a diminishing value basis over the estimated useful life of the asset using depreciation rates published by Inland Revenue. The following estimated depreciation rates have been used:

- Motor vehicles 30% DV
- Computer equipment 10% 100% DV
- Furniture and fittings 8% 100% DV
- Office equipment 13% 100% DV

An item of property, plant and equipment is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the year the asset is derecognised.

Intangible Asset

Intangible assets are carried at cost less any accumulated amortisation and any accumulated impairment losses.

Intangible assets are tested for impairment whenever there is an indication that the intangible asset may be impaired.

Income tax

Income tax is accounted for using the taxes payable method. The income tax expense in profit or loss represents the estimated current obligation payable to Inland Revenue.

Goods and services tax

The financial statements are stated exclusive of goods and services tax (GST) except for accounts receivable and accounts payable, which are stated inclusive of GST.

Comparative figures

The comparatives figures shown are for a 12 month period.

Subvention Payments

The Income Tax Act allows loss-making companies to transfer their tax losses to other companies by way of a profitable company making a subvention payment to a loss-making company where both companies meet certain requirements. AGE Limited is a member of a group of companies that meets those requirements.

Where AGE Limited is a loss-making company it records the subvention receipt it expects to receive as Subvention Receivable income in its Statement of Profit or Loss and as a current asset on its Balance Sheet in the year the receipt relates to. Where AGE Limited is a profit-making company it records the subvention payment it expects to make as Subvention Payable expense in its Statement of Profit or Loss and as a current liability on its Balance Sheet in the year the payment relates to.

Any variation between the Subvention Receivable or Subvention Payable expected is accounted for in the period the variation crystallises.

Going concern

As of 31 December 2020 the Company's current liabilities exceeded its current assets by \$2,475,835 (2019: \$1,394,369). The Company's total liabilities also exceeded its total assets by \$8,702 (2019: \$33,932) at that date.

As stated in Notes 7 and 8, the Company has loans payable to its related companies of \$4,342,773 at 31 December 2020 (2019: \$3,224,763). These loans have no fixed repayment terms. The Company has received a guarantee of continuing financial support from its ultimate parent company, and that repayment of the loans will not be required for a period of at least twelve months from the date of the approval of these financial statements.

The conditions noted above indicates the existence of a material uncertainty that may cast significant doubt about the Company's ability to continue as a going concern.

If the Company did not continue as a going concern, the Company may be unable to realise its assets and discharge its liabilities in the normal course of business. Also, additional liabilities may need to be recorded, and the Company may not recover the amount recorded for assets.

As a result of the support received from the ultimate parent company the Directors consider it appropriate to apply the going concern principle in the preparation of these financial statements.

Wilshire Treasury Ltd Loan

Repayments: repayable on demand, the directors do not expect the loan to be repaid within 12 months Interest Rate: a margin of 10 basis points (0.10%) on Wilshire Treasury Ltd cost of funds advanced Security: the Company has agreed to allow its assets to be charged by ANZ as security for a bank facility provided to Wilshire Treasury and others if requested. Wilshire Treasury Limited has registered a PPSR charge over the Company to secure its advances to the Company. The collateral is all present and after acquired personal property pursuant to a general security agreement between the debtor and the secured party dated 8 October 2018.

IRD Cashflow Loan

This loan will be repaid on 31 March 2022.

8. Related Parties

Terms and conditions of transactions with related parties:

The loan from Christian Family Trust was secured, interest bearing and was assigned to Wilshire Treasury Ltd during the year (see note 7).

The loan from Wilshire Treasury Limited is secured, interest bearing and repayable on demand (see note 7).

During the year management fees of \$100,000+gst was charged by Wilshire Investments LP.

During the year and in the prior year a subvention income was recognised from New Zealand Mail Limited amounting to \$1,065,072 and \$1,136,785 respectively.

For the year ended 31 December 2020 the company has not made any allowance for impairment losses relating to amount owed by related parties. These entities are related by way of common ownership and /or control.

The lease of the premise at 2 Sanders Ave, Takapuna has been agreed in principle between AGE Limited and Wilshire Holdings Limited, a related party, on an open market basis subject to the satisfactory completion of the refurbishment. Subsequent to reporting date, the refurbishment has been completed satisfactorily and AGE Limited started occupying the premises in January

2021 in accordance with the agreement in principle. The operating lease commitments disclosed in this Note are based on the agreement between AGE Limited and Wilshire Holdings Limited.

10. Contingent assets and liabilities

There are no contingent assets and liabilities at 31 December 2020 (2019: Nil).

11. Subsequent Events

On 1 January 2021, the School entered into a 20-year lease agreement in principle with Wilshire Holdings Limited for the lease of premises at 2 Sanders Avenue, Takapuna. Annual rent amounts to \$367,984 and final expiration with consideration of rights of renewal is on 31 December 2060. This lease agreement has been included in Note 9 Operating Lease – Future Lease Payments Under Non-Cancellable Leases.

On 1 January 2021, the School moved to the new building being leased from Wilshire Holdings Limited. As at 31 December 2020, leasehold improvements done to this building forms part of WIP. A further \$256,183 was incurred to finalise the refurbishment. Subsequently, from 1 January 2021 the WIP will be transferred to fixed assets under Leasehold Improvements and will be depreciated accordingly.

On 18 August 2021, the country went into lockdown as a result of the COVID-19 pandemic. At the date of issuing the financial statements, the school has been able to absorb the majority of the impact from the nationwide lockdown. This matter is being addressed with business continuity planning and the Board has considered that this is a "non-adjusting" subsequent event and there is no impact on the 2021 financial year.

The Company is being supported continuously by its shareholder. For this reason, the Board continues to adopt the going concern assumption in preparing the financial statements for the year ended 31 December 2020.
